Uganda: In 2018, Africa Development Promise supported 3 agricultural and 2 solar cooperatives a total of 72 women with farm inputs, technical and business training, tools and infrastructure support. In addition, we laid the groundwork to launch a vocational education program to enable individuals, enterprises or cooperatives to increase productivity and profits. Specifically, we plan to launch a computer literacy and tailoring program. ADP equipped the training center with the necessary resources, i.e. computers, audio visual, sewing machines, etc. We identified two schools that will use the training facility and developed flyers to advertise the new services that we will provide in 2019. As the program is growing, ADP also hired two additional staff members to work alongside the program manager and country director.

4b (Code:) (Expenses \$ 48,852 including grants of \$) (Revenue \$)
Rwanda: In 2018, ADP supported 2 agricultural cooperative with farm inputs, technical and business training, tools and infrastructure support. This year was also an opportunity to assess to identify and assess new cooperatives for expansion. We identified and assessed a total of 6 cooperatives and 2 community based organization and landed on adding 2 cooperatives and 1 CBO to our portfolio. Supported groups with development of a strategic plan and business plan. In addition, we completed a solar irrigation system with that pumps water to a large overhead tank that stores water for both drinking and irrigation. The water systems serves a community of approximately 85 households. In additional, ADP rehabilitated the sanitation block to the training center that was destroyed due to flooding.
